The following requirements must be met and failure to comply with any of the following may warrant disapproval of permit.

- Identification of business and address on the cart/truck.
Business name, city, state, zip code, and name of the permittee (if different from the name of the food facility) on both sides of vehicle (must match information on EMD records). The business names shall be in letters at least three (3) inches high and the city, state, and zip code at least one (1) inch high. The color of each letter and number shall contrast with its background.
- Cleanable vehicle interior.
- If occupiable, an unobstructed height over the aisle way portion of the unit of at least 74 inches from floor to ceiling and minimum of 30 inches of unobstructed horizontal aisle space.
- Food received from approved source.
- Questionnaire completed for owner grower approved source (Produce truck owner/growers)
- Freezer in good cleanable condition (frozen food trucks) or UL approved refrigeration.
- All prepackaged potentially hazardous food (PHF) except for frozen ice cream must be stored at an approved commissary. Prepackaged, non PHFs and frozen ice cream foods must be stored on vehicle in an approved manner or at approved commissary.
- Application for permit to operate (for new permit only).
- Proof of payment.
