# INTRODUCTION

The purpose of this bulletin is to inform California Accidental Release Prevention (CalARP) Program facilities of requirements that must be met when a facility undergoes a covered process modification or major change.

#### **DEFINITIONS** (California Code of Regulations (CCR), Title 19)

Section 2735.3 (v) Major change means introduction of a new process, process equipment, or regulated substance, an alteration of process chemistry that results in any change to safe operating limits, or other alteration that introduces a new hazard.

Section 2735.3 (z) Modified stationary source means a stationary source which has undergone an addition or change which qualifies as a "major change" as defined in (v) of this section.

Section 2745.11 (a) Covered Process Modification means the modification may result in a significant increase in either:

- ➤ The amount of regulated substances handled at the stationary source; or
- > The risk of handling a regulated substance

#### REQUIREMENTS FOR COVERED PROCESS MODIFICATIONS

All stationary sources must notify the Environmental Management Department (EMD) in writing at least 5 calendar days before implementing any modifications to a covered process. As part of the modification process the stationary source must do the following:

- ➤ Consult with EMD to determine whether the RMP should be revised/ updated
- > Establish procedures to manage the proposed modification, which shall be substantially similar to the procedures outlined in Sections 2760.6 and 2760.7 of the CalARP Program regulations
- ➤ Notify EMD that the procedures above have been established

# REQUIREMENTS FOR MAJOR CHANGES

## **PROGRAM LEVEL 2 FACILITIES**

UPDATE INFORMATION:	<ul> <li>Update the safety information if the major change makes the information inaccurate</li> <li>Update the hazard review whenever a major change in a process takes place</li> <li>Resolve all issues identified in the hazard review before startup of the changed process</li> </ul>
	<ul> <li>Consult with EMD on the hazard review methodology</li> </ul>
UPDATE OPERATING PROCEDURES IF:	A change in your process alters the steps needed to operate safely
EMPLOYEES AFFECTED BY THE CHANGE MUST:	Be trained on revised operating procedures prior to startup of the changed process
PROGRAM LEVEL 3 FACILITIES	
MANAGEMENT OF CHANGE (MOC) PROCEDURES	Must address:  ➤ Technical basis for the change  ➤ Impact on safety and health  ➤ Necessary time for the change  ➤ Authorization requirements

- Impact on safety and health
- ➤ Modifications to operating procedures
- ➤ Authorization requirements for proposed change

### **UPDATE INFORMATION:**

IF PSI IS UPDATED:

(PSSR) PROCEDURES

Update Process Safety Information (PSI) when a change covered by MOC procedures results in a change to any PSI

# **UPDATE OPERATING PROCEDURES IF:**

A change covered by MOC procedures results in a change in any operating procedure

#### **EMPLOYEES AFFECTED BY THE CHANGE MUST:**

PRE-STARTUP SAFETY REVIEW

- > Be informed of the change before startup
- > Trained in the change before startup

#### Must confirm:

- ➤ Construction/ equipment is in accordance with design specifications
- > Safety, operating, maintenance, and emergency procedures are in place and adequate MOC procedures are complete
- > Training of employees has been completed
