What is a Unified Program Surcharge?

The Unified Program oversees facilities that store and utilize hazardous materials in reportable quantities and/or generate hazardous wastes and includes the Hazardous Materials Business Plan, Hazardous Waste, Underground Storage Tank, Above Ground Petroleum Storage, and California Accidental Release Prevention programs.

Pursuant to Health and Safety Code, Chapter 6.11, Section 25404.5, the Secretary of the California Environmental Protection Agency (CalEPA) is required to annually determine the Unified Program surcharge to cover the necessary and reasonable costs of the state agencies in carrying out their responsibilities under the Unified Program.

Who Collects the Surcharge Fees?

The Sacramento County Environmental Management Department (EMD) implements the Unified Program for CalEPA in Sacramento County. EMD collects the surcharge fees from regulated businesses and transfers the funds to CalEPA.

What are the Unified Program Surcharges for 2017/2018?

After review and evaluation, the Secretary of CalEPA has determined that the surcharge for the fiscal year 2017/2018 for every facility regulated in the Unified Program will be as follows:

Refinery Safety (currently none located in Sacramento County)	each refinery facility	N/A	Tier 1 - \$45,000, Tier 2 - \$27,500, Tier 3 - \$13,750, Tier 4 - \$3,500	

The surcharge will appear on your invoice for annual EMD permit fees during the normal billing cycle between July 1, 2017 and June 30, 2018 and each year thereafter.
