What is the storm drainage system?	The storm drainage system includes storm drains, roadside ditches, roadside gutter pans, drainage swales and channels, and in some cases natural surface waters. The storm drainage system prevents flooding in our community by conveying stormwater into local creeks and rivers. Drains located in streets and parking lots are almost always connected to the storm drainage system.
Protecting the system	Any pollutants discharged to the storm drainage system contaminate our local waters because the storm drainage system flows directly into area creeks and rivers without being treated.
Notice of Violation	The Stormwater Inspection Notice of Violation (NOV) is issued by an Environmental Specialist for stormwater ordinance violations noted during an inspection. The NOV describes the nature of the violations and explains what must be done to correct the violations.
What you must do	Upon receiving a NOV for stormwater ordinance violations, the violations must be corrected as described on the NOV. Proof of correction must be provided to the Environmental Specialist at the Sacramento County Environmental Management Department within the time-frame specified on the NOV.
	Note: Failure to correct violations within the specified time-frame may result in an automatic re-inspection with a re-inspection fee and possible fines.
Annual Fee (SW00)	Failure to pay the stormwater regulatory inspection fee is a violation the of the following sections of local stormwater ordinances: Sacramento County (County Code Section 15.12.450); City of Citrus Heights (Municipal Code Section 98-232); City of Elk Grove (Municipal Code Section 15.12.620); City of Galt Municipal Code Section 16.10.090); City of Folsom (Municipal Code Section 8.70.320); City of Rancho Cordova (Municipal Code Section 15.12.025); and City of Sacramento (City Code Section 13.16.1500).
Prohibited discharges (SW02-SW07, WF08, WF10)	Violations that are resulting in an actual discharge to the storm drainage system (storm drains, street, or other drainage structures) or natural surface waters must be halted immediately. Any substances other than clean, potable water that have been discharged into the system must be removed, and any substances on the ground must be completely cleaned and prevented from being discharged into the storm drain system.
	Violations that have resulted in the discharge of substances other than clean, potable water or exempt substances to the storm drainage system are prohibited by to the following sections of local stormwater ordinances: Sacramento County Code, Section 15.12.200; City of Citrus Heights, Municipal Code Section 98-211; City of Elk Grove, Municipal Code Section 15.12.100; City of Galt, Municipal Code Section 16.10.070(a); City of Folsom, Municipal Code Section 8.70.120; City of Rancho Cordova, Municipal Code Section 15.12.100; and City of Sacramento, City Code Section 13.16.050.
Prohibited conditions (SW40-SW45, WF03)	Violations that have not resulted in the actual discharge of substances other than clean, potable water or exempt substances to the storm drainage system, but represent conditions that are likely to result in such discharges, are prohibited by the following sections of local stormwater ordinances: Sacramento County, Section 15.12.240: City of Citrus Heights, Section 98-215; City of Elk Grove, Section 15.12.140; City of Folsom, Section 8.70.150; City of Galt, Section 16.10.090; City of Rancho Cordova, Section 15.12.150; and City of Sacramento, Section 13.16.120.
Illicit connections (SW20)	Illicit connections to the storm drainage system are prohibited by the following sections of local stormwater ordinances: Sacramento County, County Code Section 15.12.240; City of Citrus Heights, Municipal Code Section 98-215; City of Elk Grove, Municipal Code Section 15.12.150; City of Folsom, Municipal Code Section 8.70.160; City of Galt, Municipal Code Section 16.10.070; City of Rancho Cordova, Municipal Code Section 15.12.150; and City of Sacramento, City Code Section 13.16.90.
Failure to comply	Failure to stop a prohibited discharge or to otherwise comply with the NOV is an additional violation of the local stormwater ordinance for each day the violation continues. Additional enforcement actions, including a re-inspection and a re-inspection fee, depending on the severity of the discharge and its consequences may apply. The Sacramento County Stormwater Ordinance also provides for fines of up to \$5,000 per day for continued violations. Issuance of the NOV does not prevent Sacramento County from pursuing additional enforcement actions.
Cost recovery	Businesses may be liable for costs incurred by Sacramento County or the local municipal agency in correcting, enforcing, or investigating violations.
Right to appeal	The right to appeal violations and enforcement actions is set forth in Section 15.12.540 of the Sacramento County Stormwater Ordinance. To appeal this matter, submit a written request for appeal to this office along with the appropriate fee. Call (916) 875-8440 and ask to speak with a Stormwater Specialist for more fee and appeal information. The fee will be returned if the appeal is upheld. A request for appeal must be received within 30 calendar days of receiving the NOV.
