# **NOTEWORTHY ACCOMPLISHMENTS**

# Board Approves Use of State Administrative Law Judge

EMD received approval from the Board of Supervisors to contract with the California State Office of Administrative Hearings to serve as the Hearing Officer on appeals related to solid waste regulation and enforcement activities as the Local Enforcement Agency for the California Integrated Waste Management Board.

## California State Fair Vendors

Environmental Health Division (EHD) Consumer Protection staff performed more than 100 inspections of permitted food vendors at the California State Fair.

#### **Technical Support to Board**

Supervising Environmental Specialist (ES) Steve Kalvelage provided technical support at a Board of Supervisors meeting relative to conditioning a proposed subdivision to form a septic tank maintenance district to sample groundwater and maintain septic systems.

## **Proposed Food Safety Initiatives**

EHD Chief Richard Sanchez and EMD Director Mel Knight participated in a number of meetings related to proposed food safety initiatives. A briefing was provided for the Board of Supervisors' Chiefs of Staff and meetings were held with a Food Subcommittee consisting of representatives from the food industry and the Sacramento Environmental Commission.

## Summer Food Service Program

Senior Student Intern David Chan performed 48 inspections of foodservice operations for the Summer Food Service Program. A total of 131 inspections have been performed for the Program.

## **Envision Connect Software**

IT Analysts Jim Guilliams and John Stender attended the monthly Envision User Group Meeting; Hazardous Material Business Plan handling in CUPA Programs was the main topic of the meeting. IT staff continues to test Envision Connect; one ES has received a tablet personal computer in lieu of a desktop computer as a test to evaluate the feasibility of a tablet-based system.

## Representative from Tokyo

ES Sonia Lee was accompanied on food facility inspections in downtown Sacramento by Kazuhiko Tsurumi, Japanese Delegate and Assistant Director of the Department of Food Safety, Tokyo.

#### **EMD Documents and Records**

IT staff completed Site Assessment and Mitigation backfile scanning and developed document types for Solid Waste backfile scanning.

#### Water Programs

WPD Chief Cecilia Jensen met with Herb Niederberger, Division Chief, Sacramento County Department of Water Resources (DWR), to discuss ongoing EMD/DWR coordination of water programs.

## Installation of Tidemark Software Program

Information Technology Staff completed installation of Tidemark software for select EMD users. Tidemark is a program used by the Building Inspection Division (BID) that allows EMD direct access to BID information.

## Participation in Examination Process

CMO June Livingston participated as a subject matter expert in the County's examination process for the position of Business Citizen Assistance Representative I/II.

## Solid Waste

Staff from EMD's Solid Waste Program participated in meetings to resolve the permit status of an agricultural waste facility that will soon be required to secure a State Solid Waste Facility Permit.

## Sanitary Sewer Overflows

WPD Chief Cecilia Jensen and Supervising ES Steve Kalvelage met with representatives from the City of Sacramento and the Regional Water Quality Control Board to discuss health risks and public notification relative to combined system and sanitary sewer overflows.

EMD Director Mel Knight participated in Countywide Services Agency (CSA) meetings to develop future Agency strategies and to provide information for the Human Resources audit currently in progress.

## Lead Sampling

At the request of the County Department of Transportation (DOT), ESs Barry Marcus, Rick Leibold and Jack Bellan of EMD's Site Assessment and Mitigation group performed follow-up lead sampling per DOT's agreement with Caltrans. The success of this pilot project for services has lead DOT to request similar services for another project.

## Cross-Connection and Recycled Water

WPD Chief Cecilia Jensen and ES Maria Adney met with the new security and regulatory representative of the Sacramento County Water Agency to discuss coordination on cross-connection and recycled water programs.

# Certified Unified Program Agency (CUPA)

Hazardous Materials Division (HMD) Chief Dennis Green met with CUPA Program Managers from San Diego, Los Angeles and San Bernardino Counties and representatives from the California Environmental Protection Agency, State Department of Toxic Substance Control, and Office of Emergency Services to develop a California Regulatory Performance Model. The major component of this effort is to establish risk-based protocol for CUPA programs.

## Stormwater Compliance Workshop

WPD Chief Cecilia Jensen assisted Brown and Caldwell with the development of a Stormwater Compliance Workshop for their clients and the regulated community. The Workshop is scheduled for October 2005.

# Childhood Lead Poisoning Prevention Program (CLPPP)

Supervising ES Alicia Enriquez and ES Debbie Katz met with representatives from the State Department of Health Services CLPPP, the Community Resource Project, and the Planning and Conservation League to discuss homeowner and tenant notification of available Housing and Urban Development grant monies toward elimination of lead hazards in low-income housing. Emphasis will be placed on homes being occupied by children with elevated blood lead levels.

#### Well and Septic System Requirements

Supervising ESs Steve Kalvelage and Dana Booth met with City of Elk Grove Development Services staff to discuss coordination on well and septic system requirements for new development approval.

#### San Joaquin County District Attorney's Office

HMD Chief Dennis Green and Supervising ESs Elise Rothschild, Anthony Chu and Chris Pace met with David Irey from the San Joaquin County District Attorney's Office to discuss EMD's role in recent statewide CUPA enforcement cases. EMD has been the primary provider of investigative materials for two statewide enforcement cases.
